- 1. Welcome & Introduction. Firstly, NH and PH apologised for the delay in the call starting but welcomed everyone.
- 2. Previous meeting action points from Nov 10th;
 - a. All continue to push for new members. PH to write to those non-members who attended the 'controlling machines' meeting on Jan 7th.
 - Actions relating to The Gambling Commission will be addressed in a meeting coming with Sarah Harrison. PH to also invite SH to the next GBG meeting. List of discussion points;

- i. Delays in processing changes to technical standards.
- ii. Issues in the content of the GCs annual review.
- iii. Concerns about the implementation of the new self-exclusion requirements.
- iv. Anti-Money Laundering effective risk assessment/exclusion of sectorsalong with the timing of the consultation on crime.
- v. Compatibility of Innovation and regulation.
- vi. Controlling Machines Consultation document
- c. GBG are meeting with the Better Regulation Delivery Office (BRDO) on Jan 27th to discuss 'red tape' issues.
- 3. Responsible Gambling. The call was updated on the recent RGT Harm Minimisation conference held in December, on developments with RGSB and their strategy review consultation. The call also discussed Neil Goulden's resignation from RGT and John Hagan's appointment as Chair of IGRG. PH to arrange a meeting to discuss GBG future engagement with IGRG. PH also brought everyone up to speed with the developments of a Responsible Gambling Training Accreditation further update at the next meeting.
- 4. The Gambling Commission.
 - a. Consultation on the prevention of crime. The point has been made that this consultation came out ahead of the commissions own AML risk assessment and also ahead of the treasury's consultation on AML.
 - b. Consultation on controlling where gaming machines may be played. This was the subject of much debate following a previous meeting with members and non-members on Jan 7th. PH has a meeting arranged with the Commission after this call and also the trade bodies are attending a further meeting next Tuesday. The agreement is that the GBG will re-group after those meetings to agree next steps/action.
 - c. Developments on sector local area self-exclusion were discussed. There has been no news regarding the situation with the on-line self-exclusion proposition put forwards to the DCMS by the Commission. PH to look into with the DCMS.
 - d. There was a general discussion around the recent people changes at the GC plus the inevitable change of Chair coming in 2016 and what it might mean for future regulating.

5. Government;

- a. Already mentioned that we are still awaiting the Treasury consultation on the 4th AMLD.
- b. The DCMS are still sat on the MOSES (multi operator self-exclusion solution) paper.

c. Triennial review. Ambiguous messages coming out of the DCMS. Expecting the review of the B2 £50 staking criteria first (imminently), that may partially inform a triennial review, for which there is no official timeline.

6. AOB;

- a. Clarion have almost completed the GBG website. PH/NH to review and agree final changes before going live.
- MSG. Latest revision of the Cashless Protocol that includes AML and noncashable credits (for promotional purposes) is well in progress & should be ratified at the next MSG meeting.
- c. ICE Show Feb 2nd, 3rd and 4th. PH to put out a pre-show note to members with pointers.
- d. Date of next meeting March 9th NOW CHANGED TO April 5th at 3.30pm in central London.
