#### LATEST DEVELOPMENTS ON THE GMTS

The Commission recently convened a cross-industry meeting to discuss ways to engage with the whole spectrum of the industry once the GMTS consultation is published (which will be at some point after ICE). The Commission is keen to speak to as many groups/sub groups as possible both during the 12-week consultation period and after when they are analysing the feedback. Once the consultation document is published, we will set up meetings with Members to discuss the proposals and arrange engagement with the Commission. They are happy to meet in person, via Teams and to undertake site visits to understand the implications.

The Commission is also seeking permission to use data previously provided to the DCMS strictly for its work on the Gambling Act Review. The GBG and other trade bodies are liaising with the relevant licensed machine operators as it is their data. Please contact Peter if you have any queries.

#### BARONESS TWYCROSS AT GAMBLEAWARE CONFERENCE

Members are encouraged to read the Minster's <u>inaugural formal address</u> at the recent Gamble Aware event, where every comment supporting industry growth was counterbalanced with one calling for more regulation, for example:

"I want to support the industry where the evidence suggests that it is appropriate and proportionate to do so. For example, I am very aware of the relatively modest changes being asked for by the casino sector. I support the measures outlined in the white paper and I will provide an update as soon as possible on their progress.

I also want to work closely with other parts of the land-based sector, such as bingo clubs and seaside arcades to understand what we can do to support them. They are a vital and vibrant part of many communities and I want to see them thrive, not just survive.

But growth cannot and will not be at the expense of player safety. I want to work with the land-based sector and the Gambling Commission to ensure that player protection measures, such as self-exclusion schemes, are effective and that members of staff are equipped to support those at risk of gambling-related harm".

# **GAMBLING ACT REVIEW (GAR) EVALUATION PLAN**

DCMS and the Gambling Commission have <u>published</u> an outline of a GAR evaluation plan, which set outs the evaluation aims, objectives, evaluation questions, analytical framework and research methods. The National Centre for Social Research (NatCen) has been appointed to deliver the evaluation with the report expected in 2026.
