LBO WORKING GROUP

We are delighted to announce that we held the first face-to-face meeting with the GBG's LBO working group earlier this week, involving Entain, Paddy Power, and William Hill, and look forward to supporting them and learning from them via this Group and also their involvement in other relevant GBG Groups.

GMTS

- Based on discussions with Members to date, and engagement with the other trade bodies, we are starting to draft the GBG response and will be circulating it for comments over the next few weeks. We are aware that individual Members will be making their own submissions, and we would welcome sight of those responses.
- A joint letter between the other trade bodies has been sent to the Commission seeking a two-week extension on the deadline to enable trade responses to reflect the findings from research work that is underway.

GC Data Request

You will recall that the Commission advised at the start of the consultation
process that there would be several associated data requests - made in reliance
on their formal powers under licence condition 15.3.1. They have now
completed the B2B requests and have sent the B2C data requests to holders of
non-remote AGC, betting, bingo and casino licences, seeking data on the number
and type (by Gaming Machine manufacturer name and Gaming Machine name)
of Cat B machines made available for use in reliance of your licence.

- You will note that the Commission intends to use the information to inform its
 estimation of the number of Cat Bs that, under the changes proposed, would
 have to be removed as they could not be updated to comply. To get as accurate
 a number as possible, we suggest that you assume that all the proposals will be
 implemented exactly as currently proposed.
- We also encourage you to include information about the gaming machine system/platform type in the supporting comments column so that the Commission can build up a picture about the complexity of implementing GMTS across different systems and platforms.
- Please contact the Commission (or tell us) if you have such a licence and have not received the data request. The deadline is **Tuesday 27 May 2025** (and please submit a "nil response' if you don't currently make any Cat Bs available for use).

IOL ARTICLE ON THE STATUTORY LEVY

On the topic of the Levy we are aware that the Commission has stated it will only be issuing guidance to operators on the collection and payment process and so have written to DCMS seeking clarification on who will be producing guidance on the content of the Statutory Levy Regulation, the operation of the Levy and the definitions and will update Members when we get a response. (Please note at the time of writing, the Commission has removed its guidance on collecting the Levy from its website).
